











- Webinars are very timely activities to keep rice stakeholders networked, engaged and sharing case stories.

- □ I would suggest a webinar twice a year, to keep stakeholders engaged during the COVID-19 pandemic.

### <u>Other</u>

- □ More technical support is needed for the rice sector in Africa, especially in capacity building, marketing, quality improvement and entrepreneurship.
- □ Natural disasters have a significant impact on rice fields, especially on the lowland. This issue needs to be addressed to find solutions.
- □ In the contractualization, it is important for each actor to recognize themselves as shareholders in the value chain, so that their commitments and benefits become equitable. This makes the system more sustainable.
